Abstract Selection & Review Process

All submissions will be peer-reviewed by a panel of implementation science and public health experts. The review committee will evaluate abstracts based on the following criteria:

- 1. Scientific Rigor Does the abstract describe a project that uses sound methodology?
- Relevance to Conference Themes Does the abstract align with the core themes of Driving Change: Regional Conference on Health and Emerging Fields in Implementation Science?
- 3. Innovation & Originality Is the research novel or does it present new implementation insights?
- 4. Practical Application Does the study contribute to improving public health implementation?
- 5. Clarity & Quality Is the abstract well-written and well-structured?

Final decisions on presentation type (oral & poster) will be made by the review committee.

Notification of abstract acceptance will be sent by September 15, 2025.
